Course Description

EML 5215 Analytical Dynamics I: 3 Credits.

Analytical methods of statics and dynamics. Principle of virtual work, holonomic and nonholonmic constraints. Lagrange equations for constrained and unconstrained systems, conservation laws, stability analysis by perturbation about steady state, Jacobi first integral, generalized impulse and momentum.

The objective of this course is to provide a thorough and systematic introduction to the subject of dynamics of particles and rigid bodies from a Newton-Euler and analytical mechanics perspective. The courses emphasizes a first-principles approach to the development of theory and its application to a range of problems of interest.
