### **Course Description**

Credit hours: 3; Sketching, descriptive geometry, computer graphics, computer aided design and design projects

# Course Objectives

The primary objective of the course is to educate students on the main concepts of computer-aided design: solid modeling, assembly design, engineering drawing conventions, dimensioning and tolerance specification. In addition, conceptual design skills such as creative thinking and idea illustration by sketching are taught.

The course provides mechanical systems design experience through a final project which provides the students an opportunity to develop the design of a mechanical device starting from the conceptual design all the way to detailed drawings with all dimensions and tolerances specified.

#### **In-Class Recording**
