

## **EML4600: Refrigeration and Air Conditioning Syllabus -- Fall 2021-- Section 261A**

1. **Catalog Description:** Refrigeration and air conditioning; apparatus and their applications to the industrial, commercial and residential fields (with emphasis on heavy commercial and institutional building applications).

3. **Course Objectives:** The course provides a broad coverage of refrigeration and air conditioning theory and practice in order to prepare students for a career in industry, consulting engineering practice or for further graduate studies with a specialization in refrigeration and/or air conditioning. This course will help achieve the following ABET outcomes: (1) enhance the engineering students' technical competence in mathematics, science and engineering, (2) enhance the students' ability to identify, formulate and solve engineering problems, and (3) increase the students' understanding of the impact of engineering solutions in a global and societal context and finally (4) to enhance the engineering students' ability to apply knowledge to practice.

Homework is important! Homework problems must be turned in at the start of class unless otherwise directed. Late HW will not be accepted.

### **19. In-Class Recording**

Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.
