**Course Description:** Review of plane states of stress and strain. Includes analysis of thin-walled beams with open and closed section, unsymmetrical bending of wing sections, torsion of skin-stringer and multi-cell sections, flexural shear in open and closed sections, Shear Center and failure criteria. Also includes introduction to composite materials and demonstration of behavior of some simple structural elements
