## Course Objectives:

The objectives are to provide an intermediate level coverage of the stress analysis of laminated composite plates. It stresses fundamental mechanics of materials principals to the study of anisotropic layered materials. Classical laminate theory is developed from theory through practical implementation. Additionally, the basic micromechanics of heterogeneous material systems is developed to determine the equivalent homogenized properties. Failure theories of composites are studied as well as thermal and moisture effects that lead to stress and applied to the lamina and the laminate. A survey of composite fabrication methods, common composite constituents, special considerations for experimental characterization and nondestructive evaluation is also covered. Upon completion of this course, students are expected to understand basic composite vocabulary, laminate theory and micromechanics. Additional reinforcement of linear algebra and calculus are provided.


Homework will be assigned on a weekly basis during the semester and will typically be due on Wednesdays.
