

**UF in Iceland – Renewable Energy and Sustainability**

**Spring 2022 Syllabus**

May 1<sup>st</sup> – May 8<sup>th</sup>, 2022

**Course Location:** Iceland.

**Course Description:** This is a 1-week study abroad course in Iceland. The course is based in Reykjavik, Iceland, our launching point for daily excursions to learn more about Iceland's energy infrastructure, policy and history. *Prerequisites:* None. *Credits:* 1

**Course Objectives:** Gain an understanding and appreciate the way that Iceland utilizes energy and their unique energy demands given their climate and culture. We will take daily excursions to 1) hear from energy and policy experts at Icelandic universities and non-profits, 2) tour renewable energy power plants, 3) visit Iceland's vast natural resources. Use this understanding to appreciate the differences and similarities, in terms of energy utilization and demands, between Iceland and the United States

**Relevance:** Apart from transportation, almost 100% of Iceland's primary energy consumption comes from renewable resources. This is in large part because of the unique geographical features of Iceland that enable utilization of geothermal and hydro-power for both power production and heating. However, Iceland has also implemented strategic policies for the last half century to enable its transition from an almost exclusively coal-based economy to one that is nearly CO<sub>2</sub> neutral. Understanding how this transition was accomplished in the context of Iceland and its available natural resources, will help us appreciate the necessary steps required for the United States to make similar changes. This includes economic and energy policy, educational policy and research required, that individually and combined will all play key roles in the energy transition of the next half century.

**Participation:** Participation will be based on attendance and interaction during seminars and excursion. Each day missed will result in 10% of the class average being deducted unless they are excused.

**Final Group Report and Presentations:** Students will be required to submit a one- to two-page, single spaced essay (Times New Roman, 12pt. Font) on a topic to be discussed by Prof. Scheffe. This is due on August 5<sup>th</sup> after we return from Iceland.

**Course Schedule:** We will meet daily between 9 and 10 am and return back to the hotel by around 5pm. Outside of that time you are free to explore on your own.

**In-Class Recording:** Students are allowed to record video or audio of class lectures. However, the purposes for which these recordings may be used are strictly controlled. A class lecture does not include lab sessions, student presentations, clinical presentations such as patient history, academic exercises involving solely student participation, assessments (quizzes, tests, exams), field trips, private conversations between students in the class or between a student and the faculty or lecturer during a class session.

Publication without permission of the instructor is prohibited. To “publish” means to share, transmit, circulate, distribute, or provide access to a recording, regardless of format or medium, to another person (or persons), including but not limited to another student within the same class section. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.
