Course Description

Design process, kinematics, gear trains and standard mechanical components. (3 Credit Hours)

Course Pre-Requisites / Co-Requisites

Pre-Req: COP2271, EML2322L and EGM3520 with minimum grade of C.

Course Objectives

At the end of the course, the student should

- Understand how to design using the “design process”
- Be able to determine stresses in mechanical elements
- Be able to design elements to avoid failure from static and dynamic loading within some factor of safety
- Be able to design or select standard mechanical elements
- Be able to design a one-dimensional machine, consisting of simple machines, gearing, bearings, shafts
- Have familiarity with the synthesis and analysis in mechanical design.

Homework should be taken seriously, and best effort should be applied. Be sure to read the technical writing tips on the course website. Be sure to read our comments on your homework, so that you get better. It is anticipated that there will be 7 homework assignments. Each takes time. If you wait until the last day, you will not be successful.

Participation

In light of the challenge of the pandemic, attendance is not required in the course. However, participation is required as the following discusses. The prevailing wisdom says that a student who participates will thrive in the course. The course is composed of four segments (roughly four weeks each) and each segment amounts to 100 points. Points accumulate in a vast number of ways but generally speaking: when you interact with the class or instructor. An in-lecture Canvas Quiz attempt can log your participation. Asking a thoughtful technical question in-class or via Zoom can log your participation. Or responding to such also does so. Zoom chat entries can score. The same can be said for instructor/TA office hours. Points can rack up there. A good technical email to the instructor scores. A practice Canvas Quiz attempt can log participation. In this respect, the instructor will update the class throughout each segment of the course. The instructor will use best effort to log scores consistently and uniformly. Students are encouraged to help the instructor successfully record such interactions.

In-Class Recording

A class lecture does not include lab sessions, student presentations, clinical presentations such as patient history, academic exercises involving solely student participation, assessments (quizzes, tests, exams), field trips, private conversations between students in the class or between a student and the faculty or lecturer during a class session.

Publication without permission of the instructor is prohibited. To “publish” means to share, transmit, circulate, distribute, or provide access to a recording, regardless of format or medium, to another person (or persons), including but not limited to another student within the same class section. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.

Use of Live Zoom (HyFlex)

The objectives are to meet in-person for lecture and to use Honorlock for exams and office hours. These objectives may change during the semester. In light of the challenge of the pandemic, the instructor may live stream to those who are sick or just quarantining. Associated recordings may be made. Regarding associated details, the instructor will update the class throughout the semester.
