## **Course Description**

Control methods for nonlinear systems. Lyapunov-based robust, adaptive, learning, and estimation-based methods.

# Course Objectives

This course is intended to introduce students to control methods that can be applied for the control of nonlinear dynamical systems. A Lyapunov-based framework is used as the baseline approach for the synthesis and analysis of the developed controllers. Students will learn the underlying theory derived from fundamental physics and engineering science principles. The theory will be applied to solve complex engineering problems. The course objectives will be achieved through in-class lectures, in-class examples, student completion of a project, and student completion of exams. Topics include: Solution Concepts for Nonlinear Differential Equations, Autonomous and Nonautonomous Systems, Integrator Backstepping, Input-Output Stability, Feedback Linearization, Observers and Filters, Switched and Hybrid Systems, and Robust and Adaptive Control. The content will be mathematical with illustrative examples taken from general engineering systems. The course is designed as an introductory course with no prerequisites. A general understanding of feedback systems, linear algebra, and exposure to differential equations will be beneficial. Students are expected to be able to use some simulation software (e.g., Matlab) to complete class projects.
