## **Course Description**

Single and multiple degree of freedom systems, including application to mechanical systems with problems employing computer techniques.

For the students who have completed this course to have a clear understanding of the fundamentals of mechanical vibrations of single and multiple degree of freedom systems.

### **Required Textbook**

### **Course Schedule**

Portions of Chapters 8 and 10 will also be covered. You can very clearly see the topics from the textbook. I will add some additional material, but we will generally follow the textbook. The final exam will only be given at the Registrar-assigned time on Tuesday **30 April** from **3:00-5:00**. So make your end-of-the-semester plans accordingly.
