**Course Objectives**

This course provides graduate level coverage of thermodynamics. The course stresses the fundamentals with problems of relevance to a wide range of engineering disciplines. The emphasis is on mechanical and aerospace applications. Students will learn the postulates, the use of statistical and classical thermodynamics laws in a variety of engineering applications and analyze most common thermodynamic cycles.

Publication without permission of the instructor is prohibited. To “publish” means to share, transmit, circulate, distribute, or provide access to a recording, regardless of format or medium, to another person (or persons), including but not limited to another student within the same class section. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.
