#### Course Description

Micro- and macro-mechanics, thermo-mechanical analysis and failure theories for composite materials. Design and analysis of composite structural elements.

# Course Objectives

The objectives of this course are to provide the student with (i) an introduction to composite materials and technology, (ii) a fundamental understanding of macro and micromechanical analysis of fibrous composite laminates, (iii) an overview of the use of composites in design, including their behavior under various loading conditions and (iv) an overview of the various manufacturing processes currently used to fabricate composite materials.

#### Required and Supplementary Textbooks

Required: Mechanics of Composite Materials, Second Edition, A.K. Kaw, 2006. Supplementary: Fiber-Reinforced Composites, Second Edition, P.K. Mallick, 1993.

#### Assessment Methods

Your grade for this course will be determined based on your performance on homeworks, exams and a course project:

#### Homework (weekly or biweekly assignments) 20%

Homework is to be submitted electronically on Canvas by 11:59 pm on the due date. No late assignments will be accepted. Working in groups is permitted. However, copying homework is NOT permitted. To assist the graders, homework should adhere to the following format: Each problem should start on a new sheet of paper, with a clear problem statement and the solution with reasonable significant digits inside a box. Use of solution manuals, websites or generative AI to complete homework is considered cheating and a violation of the UF honor policy.

Many homework assignments will require simple programming in Matlab or Python. The collective purpose of coding in the homework assignments will be for each student to write their own code capable of performing mechanical analysis of lamina and laminates based on materials and layup. The students will build up their code through successive homework assignments. Original code should be submitted with each homework assignment in Canvas.

# **Exams (3) 20% Each**

Exams will be two hours in length via take home assignment in Canvas.

#### Course Project 20%

Students enrolled in EAS 5242 will be required to complete a course project. The course project will be a critical literature review of a relevant topic to Aerospace Composites and Mechanics of Composite Materials. It is the responsibility of each student to propose a project topic. Topics that are related to the student's area of research or employment are acceptable. However, students may not duplicate research results or research publication for credit in this class. Students are encouraged to speak with Professor Spearot prior to submitting a project topic.

#### **Approval**

All project topics must be approved by Professor Spearot. Please submit a project title, abstract (~200 words) and an initial reference list electronically by **March 1**.

#### Report

No more than 10 pages (1 inch margins, 12 point font, 1.5 line spacing, including reasonably sized figures). Reports are due electronically to Professor Spearot by **April 1**.

#### Presentation

No more than 10 minutes to be recorded via zoom and uploaded to Canvas. Presentations will be viewed by both Professor Spearot and by the students in class. Due by **April 15**.

#### Grading

Project grades will be a composite of both written (75%) and oral (25%) reports.

#### **Grading Scale**

Course grades will be "elevated" if necessary – this decision will not be made until the end of the semester once all exams and homework assignments are graded.
