Assignments:

1. **Peer evaluation** 20% (Peer evaluation is submitted weekly starting from the first week of group work towards the end of the semester.)

Individuals with peer evaluation scores 1.5 standard deviations below the class average will get one-letter grade deduction.

Individuals with peer evaluation scores 2 standard deviations below the class average earn a failing grade in EML4700 regardless of points accumulated in the class.

- 2. Theory design weekly reports 15% (From week 2 to week 6)
 - Introduction, background and history study, overall conceptual design.
 - Subsystem design.

Each subsystem design should include conceptual design, trade studies, electrical and control system, CAD model, material selection and manufacturing methods.

- 1. wheel, leg, drivetrain, differential, steering, etc.
- 2. Robotic arm

- 3. Suspension and chassis
- Structural analysis

Optimize the dimension of critical component(s) to make sure your rover can survive 4g launch load and 6 ft drop test with a safety factor 1.5.

- **3. Manufacturing and testing weekly goal and reflection report** 5% (From week 6 until the end of the semester)
- 4. Test 35%
- 5. 90-second pitch video 5%
- 6. Final presentation 10%
- 7. Final report 10%
